## **IMMIGRATION (FEES)(NO.2)(AMENDMENT) REGULATIONS (NO.2) 2024**

*Laid before Tynwald: 18 June 2024**Coming into Operation: 01 July 2024*

The Minister for the Treasury makes the following Regulations under 68(1), (7) (10) and (12) of the Immigration Act 2014 (of Parliament)<sup>1</sup>, as that Act has effect in the Island<sup>2</sup>.

### **1 Title**

These Regulations are the Immigration (Fees)(No.2)(Amendment) Regulations (No.2) 2024.

### **2 Commencement**

These Regulations come into operation on 01 July 2024<sup>3</sup>.

### **3 Amendment of the Immigration (Fees) (No.2) Regulations 2020**

- (1) The Immigration (Fees) (No.2) Regulations 2020<sup>4</sup> are amended as follows.
- (2) In Schedule 2 (applications for leave to remain in the Isle of Man) —
  - (a) in Table 3, in the third column (amount of fee) of row 3.3.3, for “£1,500” substitute **£1,636**;
  - (b) in Table 6 (exceptions in respect of fees for applications for, or in connection with, leave to remain in the Isle of Man) after row 6.8.1 insert —

*EXPLANATORY NOTE*

*(This note is not part of the Regulations)*

These Regulations amend the Immigration (Fees) (No.2) Regulations 2020 (SD 2020/0142).

These Regulations:

- increase the immigration fee for a Worker Migrant with limited leave to remain for more than 3 years;
- introduce a new fee exception for certain applications for leave made under the Hong Kong British National (Overseas) route for those with access to public funds; and
- increase the amount of fee reduction in connection with the Health and Care route.

These Regulations maintain the Island's alignment with UK immigration fees.
